This Indian Standard (Part 9) was adopted by the Bureau of Indian Standards, takes the draft finalized by the Plastics Sectional Committee had been approved by the Petroleum, Coal and Rehard Products Division Council.

Phthalates are used as plasticizers (softening agents) in the man facture of soft vinyl [also known as not chloride (PVC)], which in turn is used in toys and childcare activities. Phthalates do are present as mobile components of the vinyl. Howards itself equate to a health risk. It is the body that can 1. body that can be harmful. Although exposure to phthalates in soft vinyl through dermal contact or inhalation is negligible, phthalates may leach an of the vinyl during periods of sustained mouthing action (sucking and chewing, but not licking) and enter the body through the saliva. Once in the body, some phthalates have the potential to cause adverse effects on reproduction system and development of child.

Earlier, the safe limits and test method for certain phthalates in toys were prescribed in IS 9873 (Part 3): 1999 through Amendment 3. The Committee has now decided to publish a separate Part under IS 9873 for the requirements of certain phthalates and to adopt ISO 8124-6: 2014 under dual numbering system for test methods for determination of phthalates.

This standard, IS 9873 has various parts under general title 'Safety of toys'. Other parts in this series are:

- Part 1 Safety aspects related to mechanical and physical properties
- Part 2 Flammability
- Part 3 Migration of certain elements
- Part 6 Determination of certain phthalate esters in toys and children's products

Further, the Committee has decided to formulate following new parts of IS 9873 which are under preparation:

- Part 4 Swings, slides and similar activity toys for indoor and outdoor family domestic use
- Part 5 Determination of total concentration of certain elements in toys
- Part 7 Requirements and test methods for finger paints
- Part 8 Age determination guidelines

## PART 9 CERTAIN PHTHALATES ESTERS IN TOYS AND CHILDREN'S PRODUCTS

### 1 SCOPE

This standard specifies maximum acceptable levels of certain phthalate esters in toys and children's products, except material not accessible.

## 3 MAXIMUM ACCEPTABLE LEVELS OF **PHTHALATES**

When tested in accordance with IS 9873 (Part 6), the toy products shall not show the presence of phthalates beyond the limits given as under:

Name of manufacturer and/or his authorized representative and/or registered trade-mark, if any.

- 5.2 The following shall be marked legibly and indelibly on toy packing:
  - a) Name of the Article;
  - b) Country of origin;
  - Manufacturer's authorized or his representative's name and address and trademark, if any;
  - d) Batch No./Code No.;
  - e) Month and year of manufacture;
  - Instructions, for use and storage as applicable (on packing/leaflet/tag, etc);
  - g) Safety directions, if any;
  - Other provisions of Regulatory Authority, as required; and
  - Usage's Age Group.
